**Subject: Extension of Exemptions/Concessions for CwSN in all Classes in compliance with CBSE Circular dated 12.04.2019 - reg.**

Madam/Sir,

Reference is invited to CBSE Circular No. CBSE/COORD/112233/2019 dated 12.04.2019 regarding exemptions/concessions extended to Persons with Benchmark Disabilities (CwSN) for Classes X & XII Examinations, in accordance with the provisions of *The Rights of Persons with Disabilities Act, 2016*. The said circular consolidates all exemptions/concessions along with the Standard Operating Procedures and supersedes earlier instructions.

It has been observed that while the prescribed concessions are being extended to CwSN students in Board Examination classes (X & XII), similar facilities are not being uniformly provided in other classes.

In this regard, it is reiterated that the spirit of inclusive education and the provisions of the RPwD Act, 2016 emphasize equitable access to learning opportunities for all CwSN students. Accordingly, the exemptions/concessions and support mechanisms prescribed by CBSE for Classes X & XII may also be extended, wherever applicable and appropriate, to CwSN students in all classes (I-XII) in Kendriya Vidyalayas.

Therefore, it is requested to:

1. Issue necessary instructions to all Kendriya Vidyalayas under their jurisdiction for uniform implementation.
2. Ensure that due procedure is followed and proper documentation is maintained.
3. Confirm that facilities are provided strictly on the basis of valid certification and as per prescribed norms.

This issues with the approval of the Competent Authority.
